Plans are required for all building types and shall be prepared by or under the direct supervision of an architect or engineer licensed pursuant to 1980 PA 299 and shall bear that architects or engineers signature and seal, except:  
1. When the electrical system rating does not exceed 400 amps and the building is not over 3,500 square feet in area.  
2. Work completed by a governmental subdivision or state agency costing less than \$15,000.00.  
Plans must be submitted before a permit can be issued.

**APPLICANT SIGNATURE** Section 23a of the State Construction Code Act of 1972, Act No. 230 of the Public Acts of 1972, being section 125.1523a of the Michigan Compiled Laws, prohibits a person from conspiring to circumvent the licensing requirements of this state relating to persons who are to perform work on a residential building or a residential structure. Violators of section 23a are subject to civil fines.

**HOMEOWNER AFFIDAVIT** I hereby certify the electrical work described on this permit application shall be installed by myself in my own home in which I am living or about to occupy. All work shall be installed in accordance with the State Electrical Code and shall not be enclosed, covered up, or put into operation until it has been inspected and approved by the New Haven Electrical Inspector. WHEN READY FOR AN INSPECTION, PLEASE FAX YOUR REQUEST TO 586-749-3408. PLEASE PROVIDE AS MUCH ADVANCE NOTICE AS POSSIBLE, BUT AT LEAST 24 HOURS IS REQUIRED.

Electrical work shall not be started until the application for permit has been filed with the New Haven Building Department. All installations shall be in conformance with the State Electrical Code. **No work shall be concealed until it has been inspected.**

A permit remains valid as long as work is progressing and inspections are required and conducted. A permit shall become invalid if the authorized work is not commenced within six months after issuance of the permit or if the authorized work is suspended or abandoned for a period of six months after the time of commencing the work. **A permit will be cancelled when no inspections are requested and conducted within six months of the date of issuance or the date of previous inspections. Canceled permits cannot be refunded or reinstated.**
