  4. Work completed by a governmental subdivision or state agency costing less than \$15,000.00.

Plans **are** required for all other building types and shall be prepared by or under the direct supervision of an architect or engineer licensed pursuant to Act 299 of the Public Acts of 1980, as amended, and shall bear that architects or engineers signature and seal. **PLANS MUST BE SUBMITTED BEFORE A PERMIT CAN BE ISSUED.**

**APPLICANT SIGNATURE** Section 23a of the State Construction Code Act of 1972, Act No. 230 of the Public Acts of 1972, being section 125.1523a of the Michigan Compiled Laws, prohibits a person from conspiring to circumvent the licensing requirements of this state relating to persons who are to perform work on a residential building or a residential structure. Violators of section 23a are subject to civil fines.

**HOMEOWNER AFFIDAVIT** I hereby certify the plumbing work described on this permit application shall be installed by myself in my own home in which I am living or about to occupy. All work shall be installed in accordance with the State Plumbing Code and shall not be enclosed, covered up, or put into operation until it has been inspected and approved by the New Haven Plumbing Inspector. **\*\*DOMESTIC WATER TREATMENT AND FILTERING EQUIPMENT:** A license is not required for the installation of domestic water treatment and filtering equipment that requires modification to an existing cold water distribution supply and associated water piping in buildings if a permit is secured, required inspections performed and the installation complies with the application code. If the enforcing agency determines a violation exists, it shall be corrected by the responsible installer. The permit application shall include the application fee, the number of water treatment devices, and the appropriate water distribution pipe (system) size fee.

WHEN READY FOR AN INSPECTION, PLEASE FAX YOUR REQUEST TO 586-749-3408. PLEASE PROVIDE AS MUCH ADVANCE NOTICE AS POSSIBLE, BUT AT LEAST 24 HOURS IS REQUIRED.

Plumbing work shall not be started until the application for permit has been filed with the New Haven Building Department. All installations shall be in conformance with the State Plumbing Code. **No work shall be concealed until it has been inspected.**

**LEAD FREE NOTICE:** The State Construction Code Act, Act No. 230 of the Public Acts of 1972, as amended, requires pipes, pipe fittings, solder or flux, which are used in the installation or repair of plumbing system in a building or structure, providing water for human consumption or a public water system, be lead free. Lead free is defined as solder or flux containing not more than 0.2% lead; and pipe and fittings containing not more than 8% lead. These provisions do not apply to leaded joints necessary for the repair of cast iron pipes.

A permit remains valid as long as work is progressing and inspections are required and conducted. A permit shall become invalid if the authorized work is not commenced within six months after issuance of the permit or if the authorized work is suspended or abandoned for a period of six months after the time of commencing the work. **A permit will be cancelled when no inspections are requested and conducted within six months of the date of issuance or the date of previous inspections. Canceled permits cannot be refunded or reinstated.**
