The image above is an example of the billing for monthly water/sewer, debt and trash services.

WATER / SEWER RATES

Explanation of charges are as follows:

Water Usage: \$4.94

Sewer Usage: \$4.26
(per 1000 gallons)

This rate represents the consumption of water used based on meter readings. It also pays for the sanitary sewer flow.

Water Debt: \$11.66

This rate represents the debt owed for the Drinking Water Revolving Fund (DWRF)

Sewer Debt: \$33.16

This rate represents the debt owed for the Macomb County North Gratiot Interceptor Drain District and Oakland-Macomb Interceptor Drain

Billing Charge: \$2.08

This rate is an itemized cost of the total preparation of the water/sewer service invoices.

Readiness to Serve: \$3.43

This flat rate is based on meter size. This charge represents the fixed costs of maintaining the water – sewer system including upgrades to the infrastructure.

Trash: \$14.92

This rate covers the cost of trash services through our contract with Waste Management, which includes curbside recycling and regular garbage pickup at the current level of service.
