2. Alterations and repair work determined by the mechanical inspector to be of a minor nature.
3. Business, mercantile or storage building having HVAC equipment only, with one fire area not more than 3,500 square feet.
4. Work completed by a governmental subdivision or state agency costing less than \$15,000.00.

APPLICANT SIGNATURE Section 23a of the State Construction Code Act of 1972, Act No. 230 of the Public Acts of 1972, being section 125.1523a of the Michigan Compiled Laws, prohibits a person from conspiring to circumvent the licensing requirements of this state relating to persons who are to perform work on a residential building or a residential structure. Mechanical work shall not be started until the application for permit has been filed with the New Haven Building Department. All installations shall be in conformance with the State Mechanical Code. No work shall be concealed until it has been inspected.			
A permit remains valid as long as work is progressing and inspections are required and conducted. A permit shall become invalid if the authorized work is not commenced within six months after issuance of the permit or if the authorized work is suspended or abandoned for a period of six months after the time of commencing the work. A permit will be cancelled when no inspections are requested and conducted within six months of the date of issuance or the date of previous inspections. Canceled permits cannot be refunded or reinstated.
